COMES NOW the Iowa Department of Public Health ("Department") and Scott Schuldt ("Petitioner"), and pursuant to Iowa Code section 17A.10 and 641 Iowa Administrative Code 131.12(7) enter into the following settlement of this matter:

1. On January 31, 2012 the Petitioner completed an affirmative renewal for certification number B-04-316-02.
2. Petitioner provided information indicating that she had completed the EMT-Basic to EMT transition requirements.
2. Petitioner has notified the department that she mistakenly acknowledged completion of the EMT-Basic to EMT transition requirements.
4. Petitioner agrees to enter into this Consent Agreement as a condition of obtaining certification as an emergency medical care provider. Petitioner waives the right to hearing and all attendant rights, including the right to appeal, by freely and voluntarily agreeing to this Consent Agreement.
5. This Consent Agreement is subject to approval of the Department. If the Department approves this agreement, it becomes the final disposition of this matter. If the Department fails to approve this agreement, it shall be of no force or effect to either party.
6. This Consent Agreement shall be part of the permanent record of Petitioner and shall be considered by the Department in determining the nature and severity of any disciplinary action to be imposed in the event of any future violations.
7. This Consent Agreement is a public record available for inspection and copying in accordance with the requirements of Iowa Code chapters 22 and 272C.
8. The Department's approval of this Consent Agreement shall constitute a FINAL ORDER of the Department and constitutes final agency action in this matter.

**IT IS THEREFORE ORDERED:**

10. The Petitioner shall surrender certification number EMT-04-316-02.
11. The Petitioner will be certified as B-04-316-02.
12. Prior to March 31, 2014, the Petitioner will complete all transition requirements identified in the Iowa EMT-Basic to EMT Documentation form available on the Department's Bureau of EMS web site at [www.idph.state.ia.us/ems](http://www.idph.state.ia.us/ems).
13. In the event Petitioner violates or fails to comply with any of the terms of this agreement, the Petitioner will be unable to renew the certification that will expire on March 31, 2014.
