The Iowa Board of Barbering (hereinafter, "Board") files this Notice of Hearing and Statement of Charges pursuant to Iowa Code §§ 17A.12(2), 17A.18(3) (2011), and 645 Iowa Administrative Code (IAC) § 11.6. Daniel Percy was issued Iowa license #14411 on May 10, 1999; Dan's Barber Shop was issued Iowa license #002987 on August 31, 2007. The licenses of both Percy and Dan's Barber Shop (hereinafter jointly referred to as "Respondents") are currently inactive.

**A. TIME, PLACE AND NATURE OF HEARING**

Hearing. A disciplinary contested case hearing shall be held on **October 25, 2011**, before the Board of Barbering. The hearing shall begin at **10:30 A.M.** and shall be located in the Lucas State Office Building, **Fifth Floor Board Conference, Room 526**, Des Moines, Iowa.

Answer. Within twenty (20) days of the date you are served this Notice of Hearing and Statement of Charges you are required by 645 IAC § 11.12 to file an Answer. The Answer should specifically admit, deny, or otherwise answer all allegations contained in sections C and D of this Notice of Hearing and Statement of Charges. Pleadings shall be filed with the Board at the following address: Board of Barbering, 5<sup>th</sup>

Floor, Lucas State Office Building, Des Moines, Iowa, 50319.

Presiding Officer. The Board shall serve as presiding officer, but the Board may request an Administrative Law Judge make initial rulings on pre-hearing matters, and be present to assist and advise the board at hearing.

Hearing Procedures. The procedural rules governing the conduct of the hearing are found at 641 IAC Chapter 11. At hearing, you may appear personally or be represented by legal counsel at your own expense. You will be allowed the opportunity to respond to the charges against you, to produce evidence on your behalf on issues of material fact, cross-examine witnesses present at the hearing, and examine and respond to any documents introduced at hearing. If you need to request an alternative time or date for hearing, you must comply with the requirements of 645 IAC § 11.18. The hearing may be open to the public or closed to the public at your discretion.

Pre-hearing Conference. Any party may request a pre-hearing conference to discuss evidentiary issues related to the hearing. The Board=s rules regarding pre-hearing conferences are contained at 645 IAC § 11.17.

Prosecution. The Office of the Attorney General is responsible for representing the public interest (the State) in this proceeding. Copies of pleadings should be provided to counsel for the State at the following address: David Van Compernelle, Assistant Attorney General, Iowa Attorney General's Office, 2<sup>nd</sup> Floor, Hoover State Office Building, Des Moines, Iowa 50319.

Communications. You may not contact board members in any manner, including by phone, letter, or e-mail, about this Notice of Hearing and Statement of Charges. Board members may only receive information about the case when all parties have

notice and an opportunity to participate, such as at the hearing or in pleadings you file with the Board office and serve upon all parties in the case.

## **B. LEGAL AUTHORITY AND JURISDICTION**

Jurisdiction. The Board has jurisdiction in this matter pursuant to Iowa Code Chapters 147, 158, and 272C (2011).

Legal Authority. If any of the allegations against you are found to be true, the Board has authority to take disciplinary action against you under Iowa Code Chapters 17A, 147, 158, and 272C (1022), and 645 IAC Chapter 21.

Default. If you fail to appear at the hearing, the Board may enter a default decision or proceed with the hearing and render a decision in your absence, in accordance with Iowa Code §§ 17A.12(3) (2011) and 645 IAC § 11.21.

## **C. SECTIONS OF STATUTES AND RULES INVOLVED**

### **Count I**

Respondents are charged under Iowa Code §§147.55, 158.9 and 158.13 (2011), and 645 IAC § 25.2, with practicing and operating a barbershop with inactive licenses in violation of 645 IAC §§ 21.9(5), 25.2(12), 25.2(26) and 25.2(27).

## **D. FACTUAL CIRCUMSTANCES**

1. Respondent Percy was issued an Iowa barbering license May 10, 1999 and Dan's Barber Shop was issued an Iowa barbershop license August 31, 2007.
2. Respondents' licenses became inactive on June 30, 2008.
3. Respondents have continued to practice barbering and operate a barbershop without active Iowa licenses.

### **E. SETTLEMENT**

This matter may be resolved by settlement agreement. The procedural rules governing the Board's settlement process are found at 645 IAC Chapter 12. If you are interested in pursuing settlement of this matter, please contact David Van Compernelle, Assistant Attorney General, at 515-281-7262.
