### ***Policy***

#### **From the WIC Services Policy and Procedure Manual – 215.95 Advising WIC Participants of Their Rights and Responsibilities**

At certification, each applicant or parent/caretaker must be advised of the rights and responsibilities of program participation, and sign a statement to that effect. By signing the statement, the applicant or parent/caretaker also agrees to allow the WIC agency to share certain information with other specified agencies.

At the time of certification, you must advise each applicant or parent/caretaker of the rights and responsibilities of a program participant. The applicant or parent/caretaker must then sign a statement that they have been:

- Advised of their rights and responsibilities, and
- Provided accurate information regarding eligibility for the WIC Program.

The document, Your Rights and Responsibilities as a WIC Participant, contains the necessary information about participant rights and responsibilities. The document is also available in Spanish. Local agencies have two options for printing this document as follows:

- Print a separate document for each certified participant, or
- Print one document per family and list the names of each person certified on the document.

Note: See Policy 215.95A for a copy of the document.

The applicant reads, signs, and dates the document after eligibility has been determined.

Note:

- Eligibility is determined after a CPA pushes certify and completes a successful certification.
- If the applicant appears to have reading difficulties, read the document to the applicant before asking for a signature.

## ***eWIC Update***

The Iowa WIC Program has been preparing for the Approved Product List (APL) requirement of eWIC. In an eWIC environment, the program must be able to provide an electronic file to all Iowa WIC approved retailers identifying all products by UPC that are eligible for purchase with WIC benefits. The tasks and equipment associated with the ability to produce and provide an APL include capture of UPC and product data and creation and maintenance of a database of Iowa WIC UPC data. Completing the APL project prior to full eWIC implementation will allow the Iowa WIC program to carefully manage the collection of UPC data to ensure that all WIC approved products are included in the APL when eWIC implementation proceeds.

### New Approaches to Treating Obesity in Higher Risk Groups

*The NWA Board Local Agency Section in partnership with the NWA Leadership Academy is pleased to announce an exciting new webinar that will take a closer look at targeted groups who seem to be at a higher risk for obesity.*

Please join [Dr. Gary Bennett](#) who will discuss findings from his [recent studies](#), which demonstrate the potential of using a "maintain, don't gain" approach with patients in groups at highest risk for obesity – racial/ethnic minorities and those who are socioeconomically disadvantaged. Dr. Bennett will argue why weight gain prevention should be the fundamental clinical priority when working with high-risk patients.

For many in these groups, there are relatively fewer health risks at low levels of obesity. However, these health risks increase dramatically as patients gain weight year after year. By maintaining weight gains, Dr. Bennett proposes that we can offset the likelihood of later life health problems. Fortunately, this "maintain, don't gain" approach can be more easily achieved than weight loss. Dr. Bennett will discuss results from his recent studies, conducted in collaboration with Piedmont Health Services, a North Carolina-based system of community health centers.
