Substance Abuse Prevention Data Usage Survey: In August 2012, SAMHSA awarded IDPH a one-year Strategic Prevention Enhancement (SPE) grant. Among other activities, IDPH must assess how programs currently use data for planning and evaluation purposes. As part of that assessment, local substance abuse prevention agencies are invited to participate in a survey developed with the input of 20 substance abuse prevention and health promotion experts. The survey is online and can be accessed by clicking here.

Based on the assessment results, IDPH will better understand both existing efforts and improvement opportunities for 1) providing prevention and health promotion staff with the information and skills needed to do their job most effectively and 2) minimizing duplication of data collection plans and programs within the state.

Assessment survey results will be shared with participants and with many others across the state and will help agencies learn more about lowa substance abuse prevention and health promotion resources.
