NOTICE OF INTENT TO SUSPEND CERTIFICATION

YOU ARE HEREBY NOTIFIED, PURSUANT TO IOWA CODE SECTIONS 272D.8, 272D.9 and 641 IOWA ADMINISTRATIVE CODE (IAC) 194, THAT:

- 1. The Iowa Department of Public Health intends to suspend your Lead Safe Renovator Certification due to the Department's receipt of a Certificate of Noncompliance from the Iowa Department of Revenue Centralized Collection Unit (Unit).
- 2. You must contact the Unit at the address or phone number in the Certificate of Noncompliance to schedule a conference or otherwise obtain a withdrawal of the Certificate of Noncompliance.
- 3. Unless the Unit furnishes a withdrawal of the Certificate of Noncompliance to the Department within thirty days of the issuance of this notice, your Lead Safe Renovator certification with the Department will be suspended.
- 4. Pursuant to 641 IAC 194.2(2) and 641 IAC 194.3(2), the effective date of the denial or suspension of a license shall be 60 days following service of the notice upon the licensee or applicant.
- 5. Pursuant to 641 IAC 194.2(4) and 641 IAC 194.3(4), you are required to keep the Department informed of all court actions and all actions taken by the Unit by providing copies to the Department within seven days of filing or issuance, of all applications filed with the district court pursuant to Iowa Code section 272D.9, all court orders entered in such actions, and withdrawals of certificate of noncompliance by the Unit.
- 6. You do not have a right to hearing before the Department, but you do have the right to contest this Notice by requesting a court hearing pursuant to lowa Code section 272D.9, within thirty days of service of this Notice.
