YOU ARE HEREBY NOTIFIED that a reinstatement hearing on your application for reinstatement of licensure will be held on July 10, 2013, at 10:00 a.m. at the Lucas State Office Building – Room 526 - 5th Floor, 321 E. 12th Street, Des Moines, Iowa. The Board is authorized to hold this reinstatement hearing pursuant to Iowa Code chapters 17A, 151, and 272C and 645 Iowa Administrative Code chapters 9, 11, and 13.

The Board shall serve as the presiding officer, but the Board may request an Administrative Law Judge make initial rulings on pre-hearing matters, and be present to assist and advise the Board at hearing. Any party who wishes to request that the presiding officer, assigned to render a proposed decision be an Administrative Law Judge must file, pursuant to 645 IAC 11.9, a written request within 20 days after service of this notice of hearing. Within 20 days of the date you are served this notice of hearing you should state whether you will require an adjustment of the date and time of your hearing.

At hearing, you may appear personally and be represented by counsel at your own expense. You have the right to produce evidence on your behalf, cross-examine witnesses, and to examine any documentary evidence introduced at hearing. The procedural rules governing the conduct of the hearing are found at 645 IAC chapter 11.


