60.2(1) An applicant shall:

f. Pass the theory examination for the particular practice discipline with a score of 75 percent or greater. The theory examination consists of 100 industry-related multiple-choice questions. Mi'Lady and Pivot Point are the textbooks used to make up the exam questions for the theory exam.

g. Pass the Iowa law (jurisprudence) examination with a score of 75 percent or greater. The law examination will consist of 25 multiple-choice questions, based on Iowa law and Iowa administrative rules.
